

OASIS SAILING CLUB DUES AND SAILING FEES

Revised June 2008

1. OASIS SAILING CLUB will bill its members at each monthly membership meetings. The billing period shall run from the close of the prior meeting until the beginning of the current meeting. All dues, sailing fees, social fees and/or other charges will become due at the meeting.
2. Membership Dues in FRIENDS OF OASIS Inc. shall be current. (Annual membership: single \$7, couple \$10)
3. OASIS SAILING CLUB membership dues shall be \$15 per month (\$45 per quarter) for all members, payable at the first general meeting of each quarter. They shall be due at the January, April, July and October membership meetings
4. All new members will pay \$25 upon joining OASIS SAILING CLUB. This will cover the first sail, club member name tag, and club hat.
5. Members who are temporarily inactive for two or more months because of illness, extended travel, or part time residence outside of Orange County, California may apply to the Board of Directors for waiver of the dues during their absence. This application must be in writing or e-mail and may be made by informal note or letter directed to the Club Secretary stating anticipated dates of absence. The Club Secretary shall present the request at the next Board of Directors Meeting for approval or disapproval and shall notify the member of the outcome. Members who have been inactive for one year or more will have their names removed from the Official Roster.
6. Members will be billed a sailing fee of \$15 for each Day Sail. Members who take guests sailing shall be billed a sailing fee of \$15 for each guest each Day Sail.
7. Members will be billed a sailing fee of \$10 for each Evening Sail (Sunset Sails, Holiday Boat Parade, Harbor Lights Cruises). Members who take guests sailing shall be billed a sailing fee of \$10 for each guest each Evening Sail.
8. Overnight cruising fees will be computed on the basis of \$90 per day per boat. Crew members will be billed a pro rata share of the cruising fee.
9. Club certified Skippers shall not be billed for their Saturday or Sunday Day Sails when they are sailing in charge of the boat.
10. New Members shall not be billed sailing fees for their first sail after joining OASIS SAILING CLUB.
11. Any member, after three months of non-payment, shall be suspended from membership. The Club Secretary shall notify the member of his/her suspension in writing or e-mail, and the suspended member shall receive no further monthly mailings. Suspended members owing only quarterly dues will be labeled eligible for reinstatement. Suspended members owing sailing or social fees will be labeled not eligible for reinstatement and must reapply for membership and pay outstanding sailing fees, social fees and monthly dues, for months in which the suspended member participated in club activities, to become active again. The Board of Directors may reinstate any suspended member. Suspended members are not eligible to sail on the Club boats as guests of active members.
12. The Board of Directors may from time to time exempt a member who has made a major contribution to the OASIS Sailing Club from paying dues and/or personal sailing fees. Sailing fees for guests shall not be excused.
